Policy Circular No. 12.41/2025 dated 23rd September, 2025

{Decision taken on E-Office File No. RSDIV/9/2025-Road Safety Division (Comp. No. 290528)}

Sub: Placement of NHAI Project Information Sign Board with QR (Quick Response) Code Sign Board and Horizontal Signs on Pavement -reg.

As per IRC Code-67-2022 and Guidelines issued by the Ministry of Road Transport and Highways dated 20.07.2023 and amended on 24.12.2024 regarding the Installation of Informatory, Cautionary and Regulatory signage on Project Stretch are being installed.

2. It is proposed to install informatory sign having QR Code Sign Board to provide relevant Project Stretch Information and Emergency Helpline Numbers as follows:



3. QR Code Specifications:

The specifications for QR code shall be as follows:

- i. Encoding Format: ISO/IEC 18004 compliant QR code.
- ii. Location specific QR Codes to be generated and downloaded from NHAI Portal after filling in the necessary Data.
- iii. Durability: Must remain readable for a minimum of 10 years or the operational life of the Board.
- iv. Maintenance: If QR Code becomes unreadable due to fading, damage or vandalism, the entire Board shall be replaced within 30 days of detection.

4. The locations for placing/fixing the QR Code Sign Board having above information of the Project Stretch are as follows:

- i. Rest Area/Way Side Amenities.
- ii. Toll Plaza.
- iii. Highway Mini Nest Area.
- iv. Truck Lay by.
- v. On shoulder Side, at 250m from start of NHAI Highway Section and 250m before the end of NHAI Highway Section.
- vi. On shoulder side, at 250m from the reassurance sign on NHAI Highway Section or 20km whichever is later




5. The details for QR Code Sign Board installation on the Project Stretches shall be prepared by the respective IE/AE and to be procured and installed by the Contractor/ Concessionaire on approval of the Concerned Project Director, NHAI. The QR Code Sign Board specifications shall be confirming to NHAI Policy Circular No. 12.38/2025 dated 19th March, 2025. The Budgetary Rate for the QR Code Sign Board is as follows:

6. Further, Horizontal Sign with Cold Applied Plastics of 2 to 2.5 mm thick (colored) are also proposed on pavement in each lane to provide information to Road Users about the Jurisdiction of Highway with NHAI. The Horizontal Sign is proposed to be provided on the following locations:

- i. At 50m from start of NHAI Highway Section in Median Side Lane and thereafter 100m on 2nd Lane, 150m on 3rd Lane, 200m on 4th Lane, etc.
- ii. Before 50m of end of NHAI Highway Section in Median Side Lane and thereafter, before 100m on 2nd Lane, 150m on 3rd Lane, 200m on 4th Lane, etc.
- iii. At location of Reassurance Sign on NHAI Highway Section or 20km whichever is later. The placement shall be same as given in (i) above.





7. The details for Horizontal Sign with Cold Applied Plastics provision on the Project Stretches shall be prepared by the respective IE/AE and to be procured and installed by the Contractor/ Concessionaire on approval of the Concerned Project Director, NHAI. The Horizontal Sign with Cold Applied Plastics specifications shall be confirming to NHAI Policy Circular No. 12.38/2025 dated 19th March, 2025. The Budgetary Rate for the Horizontal Sign with Cold Applied Plastics as follows:
